The canine trial, which is sanctioned by the Western States Police Canine Association, is being held in memory of Vallejo Police Officer Jeff Azuar. Jeff was a canine handler who lost his life in the line of duty in April, 2000. Additionally, his first canine partner, Rondo, was also killed in the line of duty while attempting to apprehend a felon.

The trials will be held at the Solano County Fairgrounds on September 23 and 24, 2005. The event will include canine handler teams from law enforcement agencies throughout California and the adjoining western states. Participating teams will compete in several different skill categories including narcotics detection, obedience, agility, search, and protection.

We believe that the police dog is one of the most valuable tools used today in law enforcement – both as a deterrent to crime and as well as apprehending those who commit crimes. The success of our canine unit is largely due to the continued support of our community. We are dependent upon community donations for our canines, their training, and their equipment. This canine trial is an opportunity for us to demonstrate the talents of our canines and their handlers and hopefully educate the community about the valuable role they play in providing public safety services to the communities they serve.
