

187 P.C. – HOMICIDE
664/187 P.C. – ATTEMPT HOMICIDE (3 COUNTS)

Suspects Maurice Don Jordan and Christina Mae Skaggs have been arrested for the November 8, 2007, homicide of Roderick Anderson and the attempted homicide of witnesses who pursued the suspect vehicle after the shooting. Vallejo Police Detectives, working with the assistance of the Anaheim Police Department and the United States Marshall's Office, located and arrested both suspects without incident in the city of Anaheim on Tuesday evening, November 13, 2007, at approximately 6:30 p.m.

187 P.C. – HOMICIDE
664/187 P.C. – ATTEMPT HOMICIDE (3 COUNTS)

Vallejo Police Department Investigators have now identified the two suspects responsible for the homicide of 24 year-old Vallejo resident Roderick Anderson. Anderson was originally located in the driveway of a residence in the 200 block of Shasta Street at approximately 7:30 p.m. on Sunday, November 8, 2007; he was found to be deceased due to gunshot wounds.

Detectives determined that the shooting was the result of an argument between two male subjects and a female, later determined to be the victim and the two suspects now wanted in this investigation. The male suspect produced an assault rifle and shot V-Anderson multiple times. The female suspect assisted the male suspect and ended up driving him away from the scene in a 2000, White Chevrolet with tinted windows and chrome rims.

The suspect vehicle was pursued by witnesses in their vehicles. Once the vehicles entered the Mariposa Street onramp in central Vallejo to westbound Interstate 80, the suspect leaned out the passenger side window of his vehicle and fired multiple rounds from the assault rifle at the pursuing vehicles, striking one of them three times. The suspects were able to escape.

The suspect vehicle and assault rifle have since been recovered, but the suspects remain at large and now have Ramey Arrest Warrants filed against them, charging the above listed offenses. The male suspect has been identified as 30 year-old Maurice Don Jordan, Jr. (Black Male, 5'9", 150 lbs), with a last known residence in Antioch, CA. The female suspect has been identified as 26 year-old Christina Mae Skaggs (White Female, 5'7", 140 lbs), with a last known address in Suisun City, CA.

No additional information is available at this time. Both suspects should be considered armed and dangerous. Suspect Jordan is currently on active parole and is also wanted by State Parole for failure to report. Their photos are attached below.
