Assistance Needed in Locating Hit and Run Driver

On 10-27-08, at 1328 hours, there was a major injury collision in the area of Sonoma and Louisiana.

A dark gray 2003 Honda Accord coupe was traveling south on Sonoma Blvd in the right lane when for unknown reasons it veered left and crossed into the north bound lanes. The gray Honda collided with a vehicle that was traveling in the left north bound lane. The gray Honda was then struck by a second vehicle that was traveling in the right north bound lane.

The driver of the gray Honda suffered major injuries and is still in intensive care. We may not be able to obtain a statement from this driver.

We have reason to believe that before the gray Honda veered across the north bound lanes that it may have been struck on the left rear by another vehicle also traveling south on Sonoma Blvd. This is based on damage located during the inspection of the vehicles.

We also believe it may have been a silver or light gray vehicle that was involved and fled the scene. This vehicle would have sustained minor to moderate damage to the right front area.

We are requesting assistance from the public and any of the local collision repair facilities in trying to locate this vehicle.

On Monday, October 27, 2008, at 1328 hours, a major injury collision occurred at Sonoma Boulevard and Louisiana.

A black Honda traveling south on Sonoma Blvd. crossed over the double yellow line into the northbound traffic lanes where it struck a vehicle that was traveling in the northbound #1 lane. The black Honda was then struck broadside on the passenger side by a second vehicle, a Hyundai, which was traveling in the northbound #2 lane.

Both the black Honda and the Hyundai sustained major damage.

The driver of the Hyundai, a 65 year old female, sustained minor injuries. She was treated at Sutter Solano hospital.

The driver of the black Honda, a 30 year old male, sustained major injuries and was transported by helicopter to John Muir hospital.

No names are being released until family notifications have been made.

The collision is being investigated by the Vallejo Police Department's Traffic Unit.
