## MOBILE HOME RENT REVIEW BOARD APPLICATION - SUPPLEMENTAL QUESTIONNAIRE

Interested applicants must complete both the Application Form and the Supplemental Questionnaire.

The qualifications, purpose, duties and powers of this commission may be found in the Vallejo Municipal Code Chapter 5.64. You may include a resume and/or additional documentation with your application. Members of this board must meet certain criteria as described in Chapter 5.64. The board shall consist of 5 members. No more than one member shall be a mobile home park owner and no more than one member shall be a mobile home tenant. Any mobile home park owner or tenant must refrain from participating in deliberations on any matter involving the mobile home park of which he or she is an owner or tenant. The Council may appoint alternate members to act when there is such a conflict of interest. The park owner need not be a Vallejo resident.

If you are the owner or the representative for a Mobile Home Park located in the City of Vallejo indicate the name and address of the park.
If you are tenant residing in a Mobile Home Park located in the City of Vallejo provide the name of the Park and the length of time you have lived at this location.
