Vallejo Municipal Code Section 5.04.365 provides that “Every contractor whether having fixed place of business within the city or not, shall have the option to pay a license tax pursuant to any of the following:

Gross Receipts include the total cost of the job or project covered by the contract to which the contractor is a party, without deduction of subcontracts and irrespective of whether the contract is one on a fixed price or on a cost plus basis or one under the terms of which the contractor acts as an agent for the owner.
